1. Terms of Sale for Digital Goods

1.1 Scope of Service

The Site provides digital product keys for in-game purchases, gift cards("Digital Goods"). By completing a purchase, you acknowledge that you are acquiring a digital license key and not a physical product.

1.2 Delivery Procedure

Upon successful payment, the following delivery protocol applies:

Method: Access key are dispatched via the email address provided during checkout.

Timeline: Delivery typically occurs within 1 to 10 minutes.

Verification: If the email does not appear in your inbox, you are required to check your Spam/Junk folders before contacting support.

1.3 Usage Restrictions and Security

One-Time Use: All access codes are strictly for one-time use only.

Transferability: You are expressly prohibited from sharing, selling, or transferring access codes to third parties.

Responsibility: Side Hustle Fintech Capital is not liable for keys rendered invalid due to customer-side security breaches or unauthorized sharing.

1.4 Refund and Cancellation Policy

Waiver of Withdrawal: Digital Goods are intangible and delivered instantly. By providing prior express consent at the time of purchase, you acknowledge that you waive your right to a cooling-off period (hesitation period).

Non-Refundable: Unless mandated by specific local regulations (e.g., accounts for minors), all completed digital deliveries are final and non-refundable.

2. Dispute and Chargeback Policy

2.1 Chargebacks
